**ORDER GRANTING DEBTOR'S MOTION FOR EXPEDITED HEARING ON
DEBTOR'S EMERGENCY MOTION TO PAY CERTAIN PRE-PETITION DEBTS TO
COMPLY WITH ALABAMA AND FLORIDA LAWS REGULATING SUPPLY OF
ALCOHOLIC BEVERAGES**
