REAPPOINTMENT OF INCUMBENT BANKRUPTCY ADMINISTRATOR

MIDDLE DISTRICT OF ALABAMA

The current five-year term of Danielle K. Greco, United States Bankruptcy Administrator for the Middle District of Alabama, expires 26 June 2024.
